Agreement Terms:

Applicants must be in good standing with both the FSA and NRCS. This project is not receiving any additional funding through FSA, NRCS or other government grants. By signing this application, you agree to all terms stated and listed.

- 2. Proof of liability insurance for the livestock will need to be provided to YCCD for this project.
- 3. This project is open to cow and calf pairs, bred cows and yearlings. Please note that there will be NO calving allowed onsite.
- 4. The timeframe for this project is 31 days. It will be held in the month of March 2023.
- 5. The cooperator will be responsible for coordination with CPW for building the electric fencing. (Fencing supplies will be supplied by YCCD and HPP)
- 6. Water will need to be hauled for cattle. Wells are available onsite if needed.
- 7. Livestock will need to be monitored and checked regularly due to the overgrowth of the area.

 Transportation for checking livestock needs to be provide as little damage to grazing area as possible.
- 8. The producer and/or employee needs to be in close proximity to the grazing project area. This project is being monitored by many and we want to do
